Nafšo d këtla darđo b siyase, kmēħšowo, ya lašan dawle w ya ste lašan šutoso bayn d cēlmo, hawila aw këtla cwodo rasmi muhim. Cam cwodo rasmi muhim kmēqṣed, i nafšo d hewyo rišo l dawle, wakilo l parlamento, riš-waziro, wakile d parlamento hadome b hayyat d gabe siyasiye yatiwe b parlamento aw b parlamento d huyogo d Awruppa (EU), hakem b mahkame clayto aw b dabara d mahkame clayto, hašwe-rišoye d parlamento, hadomo b dabara d banqa-markaziye, qonşološe, džebba t darđo cloyo (xed general, qor-general, general-cēmumi, amiral, hlof-amiral, kontēr-amiral), b šerke d dawle mdabrono mnafđono, aw hadomo b dabara, aw b šutoso bayn d cēlmo (hadomo b dabara, sakratar-cēmumi w hawxa).

Nafšo d kmēħšowo PEP, mena darđo w mena ste qudra d këtla, kibe d huwela tahluka d mitēstacmēlo b sujat d barṭi.

Aħel b cayle aw cam cawědto/cawodo idīco

I banqa, bayn d zawone d këtla, man cayli ahēlyo l nafšo d PEP aw cawědto/cawodo idīco, man kit, klozēm d udco. Cam ahēl cayli kmēqṣed aħto/gawro, hawro/hwarṭo mqayde aw yatiwe b ha bayto, emo w babo.

- nafšo cawědto cam nafšo d PEP, yacni b šarake more d ha cwodone aw b ġer šekel, hani b šerke dē cwodo, kette qudra d obi qarar cal šerke.

- nafšo hawila aw këtla calaqa qarewto cam nošo d PEP – u šewolo latyo mcalqo b calaqa d howe tajara – w
- nafšo, bas hiyya b ruha merto aw hiyya këtla qudra bi šerke dē cwodo, bu asas haṭe sēmta lašan d howe fayde l nafšo d këtyo mē PEP.

I macna d haṭe, kewyo hawxa, i banqa klozēm d maydo wěfōqo, mē nošo d këtle salahiye b mahwo d qarar bi banqa lašan d qēdro bēdyo cam i nafšo d PEP b calaqa d mucamale. I banqa klozēm d maydo madco, mena bi calaqa w mena ste bi mucamale du šuġlo d kowe, i tarwe aw u kalla d këtla lu zawono, hano mayko kote. Nafs du mede, hano hšiwoyo l ahēl d cayle w l cawode idīce d kit cam i nafšo d PEP ste.
